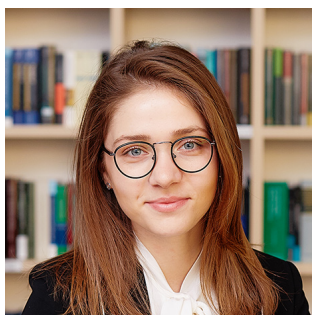

Before joining the Center, she worked in Moscow-based international law firms advising clients on international law matters for several years.

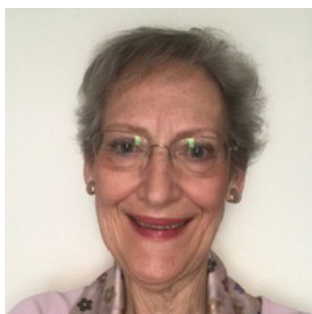


## FAUSTO POCAR

---

Judge, Professor Emeritus of International Law at the University of Milan, where he was Dean and Vice-Rector, Dr h.c. of the University of Antwerpen and the Kennedy University of Buenos Aires. Judge Pocar has a long experience with the UN, both as an Italian delegate (General Assembly, HR Commission, COPUOS) and as a member of UN bodies and courts: HR Committee under the ICCPR (1984–2000), Judge of the ICTY (2000–2017) and of the Appeals Chamber of the ICTR (2000–2015). Judge Pocar was also President of some of these UN bodies and tribunals. As of 2017, he is an *ad hoc* Judge of the ICJ.

He is a member of the Bureau of the Institut de Droit International, President of the Italian Society of International and EU Law, Honorary President of the International Institute of Humanitarian Law, and Vice-president of the Human Rights Commission of the National Academy “Lincei”. In 2014 he was awarded the Great Cross Knighthood by the President of Italy.



## GABRIELLA VENTURINI

---

Professor Emerita of International Law, University of Milan, President of the Italian Branch of the International Law Association (since 2013), member of the Council of the International Institute of Humanitarian Law (since 2019). Professor Venturini taught and wrote extensively in the field of public international law including International Humanitarian Law and Human Rights Law, International Disaster Law, Disarmament and Non-proliferation, Space Law, International Trade Law, and EU Law.



## **BAKHTIYAR TUZMUKHAMEDOV**

Professor of International Law, Vice-President of the Russian Association of International Law, Member of the Committee Against Torture, Member of the Council of the International Institute of Humanitarian Law. Appeals Judge at the UN International Criminal Tribunals for Rwanda and for the former Yugoslavia (2012–2015), Trial Judge at the UN International Criminal Tribunal for Rwanda (2009–2012), Adviser to the Russian Delegation to the UN Special Committee on Peacekeeping Operations (2008), Civil Affairs Officer with the UN Peace Forces in the former Yugoslavia (1994–1995).

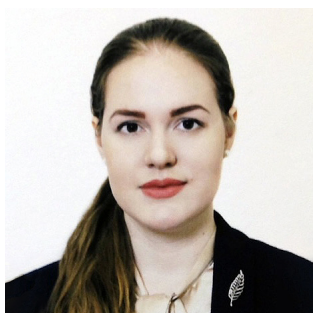


## **GIORGIO BATTISTI**

---

Lieutenant General Italian Army (Ret.), Vice-President of the International Institute of Humanitarian Law. His last assignment was Commander Italian Army Training and Doctrine Command in Rome. General Battisti served in command and leadership positions from platoon through Corps and Army Command, including the “Taurinense” Alpini Brigade and the NATO Rapid Deployable Corps (Italy).

Throughout his career has held multiple command and staff positions in Italy and abroad, took part in the UN mission to Somalia in 1993, and the NATO one to Bosnia in 1997. Furthermore, General Battisti deployed to Afghanistan four times, in 2001/02, 2003, 2007, and 2013/14. During his last tour of duty in Kabul General Battisti served as ISAF HQs Chief of Staff.



## **LILIYA ROMADAN**

Diplomat, employee of the Embassy of the Russian Federation in the Republic of Moldova. Member of the Russian Federation delegation to the Joint Control Commission (the governing body of the peacekeeping operation in the Transnistrian region of the Republic of Moldova). Candidate of Political Science. In 2019, she defended her thesis “Evolution of UN peacekeeping at the end of XX the beginning of the XXI century (on the example of the African continent)”. Author of publications in the field of peacekeeping activities of international organizations. Member of the Council of Young Diplomats of the Ministry of Foreign Affairs of the Russian Federation.
